2 The founders of the Trust together with the nominated trustees will form the members of the Board of Trustees of the **'AL-HUDA EDUCATIONAL AND CHARITABLE TRUST'**.

3. In order to effectuate the said object of creating and establishing a Public Charitable Trust within the state of Kerala, the founders of the trust have contributed and made over to the Trustees a sum of Rs.1,000/- [Rupees one thousand only] to have and to hold the same and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as "THE TRUST PROPERTY" for the charitable objects and purposes and uses herein contained of and concerning the same.

4. The objects of the Trust shall be:-

1. *To establish, promote, set-up, run and maintain schools, colleges and other educational institutions for the benefit of the public irrespective of caste, creed, colour, religion, community, place and region;*

2. *To give, provide and/or render help any assistance in cash or kind to students belonging to weaker sections of the society.*

3. *To open, found, establish, promote, set-up, run, maintain, assist financial support and/or aid to or help in the setting up and/or maintaining and or running institutions or centers for rendering or providing medical relief and/or aid to the suffering humanities.*

4. To give, provide and/or render help and assistance in cash or kind to poor, needy and/ or destitute people, widows, etc.

5. To give, provide and/or render monetary and/or other help and assistance to and /or implement any scheme for providing livelihood and uplift of the poor and weaker sections of the society.

6. To give, provide and/ or render food, medicine and other help and/or assistance in any shape or form to the poor deserving and needy persons.

7. To renovate or repair or assist or run any place for public worship.

8. To promote, assist and/or maintain all activities by whosoever carried on or wherever carried or in India in conformity with the objects of the Trust and as are conducive to the well being and general welfare of the nation or are conducive for advancement of any object or objects of general public utility.

9. To establish and execute scholarship schemes for the meritorious students from among the public in general and backward communities in particular.

5. If any one or more of the objects specified in clause (4) of these presents are held not to be objects of a public charitable nature, the trustees shall not carry out such object or objects as if the same are not incorporated in these presents but the validity of the trust created by these presents as a trust for public charitable purposes shall not be affected in any manner.

6. The board of trustees may accept any donations or contribution in cash or in kind from any person, firm, company, associations or institutions for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust.

7. The board of trustees may as per decision taken in 2/3rd majority in any meeting of the Board of Trustees may nominate any person as Trustee to the Board of Trustees.

8. The board of trustees mentioned above may elect in majority if it becomes necessary a Chairman, Vice Chairman, a Secretary, Joint secretary and a Treasurer from themselves and the board shall make necessary arrangements for the management of the Trust.

9. The board of trustees may as per decision taken in majority in any meeting of the Board of Trustees form any sub committee among the Trustees for any particular objects or for the management of any institution run by the Trust and the number of the members for such sub committee shall not be less than three.

10. The Board of Trustees may frame any rules and regulations for the management of any of its institutions and such rules shall not be inconsistent with the objects of the Trust.


11. The Board of Trustees as per decision taken in majority in any meeting of the Board of Trustees may appoint any person among the Trustees or as per decision taken in 2/3rd majority any fit and competent person other than Trustee as the Manager for the day to day management of any of the institutions functioning under the trust.

12. Without affecting the generality of powers and functions of the trustees to manage and administer the trust, the Board of Trustees shall have the following functions:-

i). To borrow if needed be against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided the board of trustees agree on such borrowing and limited to the terms of their decision or agreement and to authorise two or more of the trustees to execute such documents, deeds, papers, etc as may be necessary in connection therewith.

ii). To arrange for and/ or authorise the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or executed on behalf of the trustees by any two of the trustees to be nominated in this behalf by the board of trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.





iii). To spend any portion of the corpus or the income of the trust fund for purchasing any land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and/or executing any or all the objects of the trust.


iv). To appoint or make provision for the appointment of a sub-committee of trustees and/or others to attend to or supervise or conduct, specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the board of trustees may decide.

13. The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties.

14. The accounts of the Trust shall be audited by competent persons in every year

15. The board of trustees; if decided by 2/3rd majority shall be at liberty to sell such portion or portions of the movable and immovable properties forming part of the Trust Estate either by public auction or private sale at such price or prices and in such terms and conditions as they may in their absolute discretion think fit and proper and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges for all moneys received by them.





16. Bank account / accounts shall be opened in the name of the Trust with any bank or banks and it shall be operated by the Chairman, Secretary and the Treasurer jointly on behalf of the Trust, and the cheques and other necessary documents shall be signed by any two of them.

17 All the records of the Trust will be kept at the Registered office of the Trust and the secretary will be in charge of the records.

18. The trustees may from time to time frame schemes and rules and regulations to carry out the objects of the trust and for managing the affairs of the trust and otherwise for giving effect to the objects and purposes of the trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper.

19. The trustees shall be entitled at their discretion from time to time start, discontinue, abolish and re-start any program, scheme, course, institution, or anything started or conducted as per the objects of the trusts and to impose any fees, condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust property or income for any particular object.

20. Subject to the conditions aforementioned the Board of Trustees may in majority make and alter rules and regulations with regard to the management of the trust and all matters in respect of which any power or duty is hereby vested in them.

21. All the trustees unless they voluntarily resign or otherwise decide, shall continue to be trustees during the term of their natural lives.

22. The Board of Trustees may, by 3/4 th majority vote of all the trustees for the time being except the trustee proposed to be removed, remove any trustee, permanently or otherwise, from office on any reason and the decision of the Board of Trustees in this behalf shall be final and binding and shall not be called in question anywhere.

23. The number of Trustees shall be not less than seven and not more than fifty.

24. Any trustee may retire at any time without assigning any reason.

25. The surviving or continuing trustees may notwithstanding any vacancy in their board act as trustees provided however that if the number of trustees shall fall below seven the minimum fixed by these presents, the trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.

26. Seven trustees at the Board of Trustees meeting and one third of the total trustees at a general body meeting shall form its quorum for the respective meetings. The quorum for removing any Trustee from the Trusteeship as stated above shall be 3/4 members of the total Board of Trustees except the trustee to be removed.







27. The usual meeting of the Board of Trustees will be held once in three months and meetings will be convened by the secretary and in the absence of the secretary the chairman can convene the meeting. The extra ordinary meetings will be held within 24 hours notice and the usual meetings will be convened in 3 days notice.

28. Usually the chairman will preside over the meetings. Minutes of the meetings will be prepared and will form part of the records.

29. In case of difference of opinion between the trustees the opinion of the majority shall prevail.

30. All meetings of the trust shall be held at such place and at such time as the secretary of the trust shall decide from time to time.

31. In case any vacancy in the Board of Trustees arises by death, resignation or otherwise, the same shall be filled up by nomination by the remaining trustees as per 2/3 majority decision.

32. On a new or additional trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the Trust property shall automatically vest in him along with the other trustees for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed or writing.


